SRI LANKA INSTITUTE OF LOCAL GOVERNANCE ACT, No. 31 OF 1999

Order under Sub-section (1) of Section 22

I, Janaka Bandara Tennakoon, Minister of Local Government and Provincial Councils, hereby approve the proposed acquisition under Sub-section (1) of Section 22 of the Sri Lanka Institute of Local Governance Act, No. 31 of 1999 that the land described below is required for a public purpose namely to locate Sri Lanka Institute of Local Governance.

SCHEDULE

All that divided and defined allotment of land marked Lot 1, together with the Upstairs Residential house bearing Assessment No. 43, Horton Place, (being a re-survey of the amalgamation of Lots 1, 3 and depicted in Plan No. 1071 dated 14.03.1941 made by D. Wickremarathne, Licensed and fiscals Surveyor), situated at Horton Place, in Ward No. 36 (Cinnamon Gardens) in the Palle Pattu of Salpiti Korale, within the Municipality and District of Colombo, Western Province, in which said Lot 1 in Plan No. 3118 dated 05th August, 1982 and made by H. Anil Peiris, Licensed Surveyor, together with the Upstairs house standing thereon, is bounded on the North by premises bearing Assessment No. 46, Barnes Place, East by premises bearing Assessment No. 45/3, Horton Place and Lot 2 (reservation for road), South by Horton Place and Lot 2 and on the West by premises bearing Assessment No. 37, 39/3, and 41, Horton Place and containing in extent One Rood, Twenty Eight Perches (0A., 1R., 28P.) according to the said Plan No. 3118.

Together with the full and free right liberty over the reservation for road Thirty feet wide marked in the aforesaid Plan No. 3118 as Lot 2 being a re-survey of the reservation for Road 30 feet wide depicted in Plan No. 1071 situated at Horton Place in Ward No. 36 (Cinnamon Gardens) within the Municipality and District of Colombo, Western Province and which said Lot 2 is bounded on the North by Lot 1, East by premises bearing Assessment No. 45/3, Horton Place and Lot 3 and 5, South by Horton Place and on the West by Lot 1 and containing in extent Twenty Three decimal One Two Perches (0A., 0R., 23.12P.) according to the said Plan No. 3118.
