FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE ALLAWWA PRADESHIYA SABHA UNDER SECTION 65A (2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the office of a member in Alawwa Pradeshiya Sabha has fallen vacant by reason of not attending meetings of the council for a period of three months without permissions ;
