**DEARNNESS ALLOWANCE PAYABLE TO LABOURERS COVERED BY THE PROVISIONS OF THE MINIMUM WAGES (INDIAN LABOUR) ORDINANCE (CHAPTER 135), BUT TO WHOM WAGES BOARDS DECISIONS DO NOT APPLY**

IT is hereby notified for general information that the Dearness Allowance payable for each working day in the month of March, 2006, to a Labourer, covered by the provisions of the Minimum Wages (Indian Labour) Ordinance, but to whom minimum wages are not payable, is as follows:
