#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under section 5

I, Rajitha Senarathna Minister of Lands hereby Declare under Sub-section 1 of section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.
