THE FAUNA AND FLORA PROTECTION ORDINANCE (CHAPTER 469)

Order under Sub-section (1) of Section 2

BY virtue of the powers vested in me by Sub section (1) of Section 2 of the Fauna and Flora Protection Ordinance (Chapter 469), I, Maithripala Sirisena, Minister of Agriculture, Irrigation and Mahaweli Development and Environment, do by this Order :-

- (1) declare the area of State land described in the Schedule hereto to be a National Reserve for the purposes of the aforesaid Ordinance ; and
- (2) declare that such area of land as is described in the Schedule hereto, shall be a National Park and shall hereafter be called and known as the “Lahugala - Kithulana National Park” ; and
- (3) declare that the Order published in Gazette No. 10,538 of October 31, 1980 is hereby rescinded.

SCHEDULE

LIMITS OF THE LAHUGALA - KITHULANA NATIONAL PARK

All that area of State land situated within the Lahugala Divisional Secretary's Division in the Administrative District of Ampara of the Eastern Province, containing in extent 5131 Hectares and bounded as follows :-

- South :* Upto the place where a line drawn parallel to the Moneragala - Pothuvil Main Road from a point about four hundred metres to the North of the 196th milepost and thenceforth towards the West, meets the Eastern limit of the upper water level of the Kithulana Wewa along the above line drawn parallel to the said road ; from there onwards to the South along the said water level limit upto the Eastern end of the bund of the said tank, from there towards the West along a straight line upto the aforesaid road ; from there towards the West along the said road upto the 192nd milepost and from there towards the West along a straight line upto the place where it meets the right bank of the Heda Oya ; from there towards the North - West along the right bank of the said Oya upto the point where a straight line is drawn towards the South from the 189th milepost on the aforesaid Moneragala - Pothuvil Main Road to meet the right bank of the said Oya ;
- West :* Upto the point where a straight line drawn from the last point of the Southern boundary to the North across the place where the 19th milepost on the Moneragala - Pothuvil Main Road is situated and meets the left bank of the Karanda Oya ;
- North :* Upto the point where a straight line drawn from the last point of the Western Boundary to the East along the left bank of the Karanda Oya from the Northern end of the Bund of the Sengamuwa Wewa towards the North and meets the left bank of the Karanda Oya ;
- East :* Along the straight line drawn from the last point of the Northern boundary to the South upto the Northern end of the Bund of the Sengamuwa Wewa and from there to the south along the bund upto the Southern end and from there to the South along the straight line up to the point where the Southern boundary starts.
