THE URBAN DEVELOPMENT PROJECTS (SPECIAL PROVISIONS) ACT No. 2 OF 1980

Order Under Section 2

BY virtue of the powers vested in me under Section 2 of the Urban Development Projects (Special Provisions) Act No. 2 of 1980, I, Percy Mahendra (Mahinda) Rajapaksa, President of the Democratic Socialist Republic of Sri Lanka, upon the recommendation of the Minister-in-charge of the subject of Urban Development, being of opinion that the land specified in the Schedule hereto is urgently required for the purpose of carrying out an urban development project for the development of a hospital complex and related activities, do by this Order declare that the said land is required for such purpose.
