THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

By virtue of the powers vested in me under Section 5 of the Land Acquisition Act, as amended by Land Acquisition (Amendment) Act No. 28 of 1964, I, Chamal Jayantha Rajapaksa, Minister of Agriculture Development do hereby declare that the land described below will be acquired under provisions of the said Act as it is required for a public purpose:

Description of the land:

All that allotments of land, approximately a total extent of 0.2402 Hectares, in the Advance Tracing No. MAHA/TMP/2003/573 and dated 23.10.2003, prepared by Surveyor General, situated in the village of Bonacot, within the Thumpane Udapattuwe Minor Division, Thumpane Divisional Secretary's Division in the Kandy District, the names, extents and boundaries of which are shown below.
