##### Declaration under Section 5

I, Chamal Jayantha Rajapaksha, Minister of Agriculture Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Dissanayake Mudiyanseelage Anura Kumara Dissanayake, Minister of Agriculture, Livestock, Lands and Irrigation do hereby declare under Sub section (1) of Section 5 of the Land Acquisition Act that the servitude described in Paragara I hereunder is required for a public purpose and will be acquired under the provisions of that Act. The land over which such servitude is to be acquired is described in Paragraph II.

**I. Description of the Servitude:** For the access road, laying and Maintenance of pipelines.

**II.
