THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Chamal Jayantha Rajapaksha, Minister of Agriculture Development, do hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

An allotment of land Koswatta called in total extent of about 4.7548 Hectares, depicted in Advance Tracing No. H/TNG/2005 271 and dated 26.09.05 prepared by the Surveyor-General situated in the village of Morakatiara in Giruwapattuwa South Minor Division in the Divisional Secretary's Division of Tanagalle, in Hambantota District and bounded as follows:

North: 366200 and 33391 Arehena; East: Spancchiwatta; South: Koskoratuwa, Kosgahahena and Piscawatta; West: Piscawatta.

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Chamal Jayantha Rajapaksha, Minister of Agriculture Development, do hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Three lots of land, Lots A, B and C in extent of about 1.3180 Hectare out of whole extent of Land depicted in Advance Tracing No. KU/IBB/2001/294A, prepared by the Surveyor-General, dated 2003.04.22, situated in the village Galkaduwa West (F. V. P. 1174A) in Ihala Visideke Korale Minor Division in Ibbagamuwa Divisional Secretariate area in Kurunegala District in the North Western Province and bounded as follows:

1. Lot A – Diulgahamulawaththa – Extent: 0.1659 Hectare

North: The land of Ibbagamuwa Model School; East: Lot B; South: Lot C and Kadewaththa of Asan Hameed; West: The land of Ibbagamuwa Model School and Halmillagahamulla Waththa of N. L. M. Farhan.
