#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Chamal Jayantha Rajapaksha, Minister of Agriculture Development, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Three (03) allotments of land in extent about 0.0152 Hectare, depicted in Advance Tracing No. KA/BRW/05/637 and dated 28th December, 2005, made by Surveyor-General, situated in the village of Kudapayagala in Divisional Secretary's Division of Beruwala in the District of Kalutara and bounded as follows:
