STATEMENT OF MATTERS IN DISPUTE

The matters in dispute between the aforesaid parties are -

- (1) Whether the demotion to the Grade IV with effect from 06. 05. 2005 by the National Savings Bank, of the four (04) employees namely, Messrs. W. M. Gunawardane, W. M. Sarath, D. A. P. Dissanayake and W. G. Wasantha Kumara while they were serving in the post of Grade III of Class III of the said Bank is justified and if not, to what relief each of them is entitled, and
- (2) Whether the demotion to the Grade VII with effect from 06. 05. 2005 by the National Savings Bank of Mr. N. Prabath Indrajith while he was serving in the post of Grade VI of the said Bank is justified and if not, to what relief he is entitled.
