THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Chamal Jayantha Rajapaksa, Minister of Agriculture Development, do hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Land called Kolamune Kumbura, in extent about 1.1913 Hectare, shown in Plan No. 410 of dated 20.11.1995, prepared by the Licensed Surveyor Mr. R. A. V. Cooray, situated in Pepiliyana Village, in the Grama Niladhari's Division of Gangodawila, in Palle Paththuwa Minor Division, in the Divisional Secretary's Division of Maharagama, Colombo District and bounded as follows:

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Chamal Jayantha Rajapaksa, Minister of Agriculture Development, do hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for a public purpose.

Description of the land to be acquired:
