THE LAND ACQUISITION ACT (CHAPTER 460)

Notice under Section 7

I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for a public purpose.

Description of the land to be acquired :

An allotment of land called Palleshottabedda in total extent of 2.097 Hectares, (05A. 0R. 29.1P), depicted in Preliminary Plan No. G. 3489, prepared by the Surveyor-General, situated in the village of Thalagasgoda in the Divisional Secretary's Division of Ambalangoda in the Galle District and bounded as follows:

North: Godahena Road, Akkara-hatha claimed by M. H. Ranjith, N. W. Hemantha and S. G. Kusumawathie (P. 127899), Akkara Dahaata claimed by L. H.
