THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Chamal Jayantha Rajapaksa, Minister of Agriculture Development, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Five (05) allotments of land shown as Lot Nos. 314, 315, 316, 317 and 318 in total extent of about 0.2509 Hectare, depicted in Suveyor-General's Plan No. F.V.P. 26, dated of 02nd March, 2006, in the Grama Niladhari's Division in 229, Vellamanal in Town and Gravets Divisional Secretariat in the Trincomalee District and bounded as follow :
