THE LAND ACQUISITION ACT (CHAPTER 460)

Notice under Section 7

Reference No.: Wa/18/63/2003.

I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for a public purpose.

Description of the land to be acquired:

Five (05) allotments of land, called Telambugaha Watta *alias* Millagaha Watta and Thun Havul Kekunagaha Watta, in total extent of about 2.6847 Hectares, shown in Preliminary Plan No. Gam. 3504, prepared by the Surveyor Superintendent of Gampaha District, situated at Heenkenda Village in the Sub Division of Ragam Pattuwa in Wattala Divisional Secretary's Division in Gampaha District of Western Province.
