### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Chamal Jayantha Rajapaksa, Minister of Agriculture Development, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Eleven (1-11) allotments of land in total extent of about 3.700 Hectares, depicted in Advance Tracing No. KU/GNW/2005/173 of 30th of August, 2005, prepared by the Surveyor-General, situated in the village of Seerangoda in the Divisional Secretary's Division of Ganewatta in Kurunegala District and bounded as follows.

01. Lot 'A' – **Moragodayaya – Extent: About 0.071 Hectare**  
North: Mirihana Kotuway Ela and Pothuwagonna Village; East: Pothuwagonna and Village Lot C; South: Lot C; West: Lot C, D and Ela.

02. Lot 'B' – **Moragodayaya – Extent: About 0.038 Hectare**  
North: Pothuwagonna Village; East and South: D. Premathilaka's Moragodayaya Land; West: Lot F and C.

North: Mirihana Kotuway Ela and Lot D; East: Lot C, F, and H; South: Lot H; West: Mirihana Kotuway Ela.

06. Lot 'F' – **Moragodayaya – Extent: About 0.521 Hectare**  
North: Lot C; East: S. W. Hemachandra Rathnayaka's Moragodayaya Land, K. A. Gunathilaka's Moragodayaya Land and Lot G; South: Lot G and H; West: Lot H. E. and C.

07. Lot 'G' – **Moragodayaya – Extent: About 0.386 Hectare**  
North: Lot F; East: K. A. Gunathilaka's Moragodayaya Land; South: K. A. Gunathilaka's Moragodayaya Land and Lot L; West: Lot H and F.

08. Lot 'H' – **Moragodayaya – Extent: About 0.725 Hectare**  
North: Lot E, C and F; East: Lot F and G; South: Lot L; West: Lot K.

09. Lot 'J' – **Moragodayaya – Extent: About 0.362 Hectare**

**THE LAND ACQUISITION ACT (CHAPTER 460)****Declaration under Section 5**

I, Chamal Jayantha Rajapaksa, Minister of Agriculture Development, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for a public purpose.

**Description of the land to be acquired:**

An allotment of land called Alawattaketiya Hena, bearing total extent of about 0.1342 Hectare, depicted as Lots A, B and C in the Advance Tracing No. Maha/PTH/2006/04 and dated 10th May, 2006, prepared by the Surveyor General, situated in the village of Udamailapitiya in the Minor Division of Hewawissa Korale in the Divisional Secretary's Division of Pathahewaheta in Kandy District and bounded as follows

**01. Lot 'A' – Alawattaketiya Hena – Extent: About 0.0374 Hectare**
