EXCISE (SPECIAL PROVISIONS) ACT, No. 13 OF 1989

Order under Section 3

BY virtue of the powers vested in me by Section 3 of the Excise (Special Provisions) Act, No. 13 of 1989, I, Mahinda Rajapaksa, Minister of Finance and Planning, do by this Order specify that with effect from 11th April, 2007, the rate of excise duty payable on a motor vehicle falling within the H.S. Headings and H.S. Code specified in Column I and Column II of the Schedule hereto, imported by an officer on concessionary duties and taxes under the Trade, Tariff and Investment Policy Circular No. 01 of 30.03.2007, issued by the Secretary to the Treasury and any amendments made thereto from time to time, shall be as specified in the corresponding entry in Column IV of that Schedule.
