#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act:

Three (03) allotments of land in total extent of about 0.213 Hectare, depicted in Advance Tracing No. KA/WLL/96/195 of Lot A, B, C prepared by the Surveyor-General situated in the village Lihinyawa in Minor Division of Mahapattuwa South in the Divisional Secretary's Division of Walallawita in Kalutara District and bounded as follows:
