## PART IV (A) — PROVINCIAL COUNCILS

### Provincial Councils Notifications

#### NORTH CENTRAL PROVINCE PROVINCIAL COUNCIL

##### Notification

BY virtue of the powers vested in me under Section 184 (1) (c) (e) (f) of the Pradeshiya Sabha Act, No. 15 of 1987 to be read with Section 2 of the Provincial Council (Incidental Provisions) Act, No. 12 of 1989, I, Berty Premalal Dissanayake, Chief Minister and the Minister in Charge of the subject of Local Governments of the North Central Province, do hereby make following regulations in respect of the allowances to Chairmen, Vice Chairmen and Members of Pradeshiya Sabhas. These regulations shall come into effect from the 06th day of May, 2007.

##### REGULATIONS

#### 1. *Imposition of fuel limits for Chairman of Pradeshiya Sabha on official travelling:*

- (i) If a Pradeshiya Sabha vehicle is used, expenses may be incurred by a Pradeshiya Sabha consisting of a Divisional Secretary's Division for not more than 400 liters of diesel a month ; or
- (ii) By a Pradeshiya Sabha consisting of two Divisional Secretaries' Divisions for not more than 500 liters of diesel a month,
- (iii) Where there is no vehicle in the Pradeshiya Sabha, expenses may be incurred from the fund of the Council with the approval of the Commissioner of Local Government for private vehicles subject to the limit of expenditure on fuel above.

2. *Travelling and Combined Allowances:*

- (iv) A Combined Allowance of Rs. 500 per each full day may be paid to the Chairman of the Pradeshiya Sabha, subject to the provisions of the Establishments Code, and such Combined Allowance may be claimed subject to a maximum of 10 days a month.
- (v) Combined Allowance is paid only for official travelling out of the jurisdiction of the Pradeshiya Sabha. These allowances shall be made in compliance with the provisions of the Establishments Code.
- (vi) Combined Allowance is not paid for travelling within the jurisdiction of the Pradeshiya Sabha.
- (vii) Travelling and Combined Allowance as referred to above shall only be claimed for travels in execution of duties directly involving the functions of the Pradeshiya Sabha. Nobody is entitled to claim from the Fund of the Pradeshiya Sabha travelling and/or Combined Allowance for travels to participate in any ceremony, conference or meeting on official invitation for such ceremony ; conference or meeting, which has no relevance to the functions of the Pradeshiya Sabha.

3. *Entertainment Allowances :*

- (i) A monthly Entertainment Allowance of Rs. 1,000 may be paid to Chairmen of Pradeshiya Sabhas out of the Fund of the Council and the object code has to be submitted for the purpose.
- (ii) Expenses may be incurred out of the Fund of the Council for refreshments to the Members attending the meetings of the Pradeshiya Sabha, subject to a maximum limit of Rs. 50 per each Member for a sitting.

4. *Telephone Allowance :*

- (i) Permission is granted for the Chairman and the Vice-Chairman of the Pradeshiya Sabha to obtain an Allowance out of the Fund of the Council for his residential telephone, subject to following limits :
