THE LAND ACQUISITION ACT (CHAPTER 460)

Notice under Section 7

I, hereby give notice, under Sub -section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for a public purpose.

Description of the land to be acquired :

The land called Endarugollewewatta situated in the village of Panliyadda shown as Lot No. 444 in FVP (Sheet No. 17, Supplement No. 17) in the Grama Niladhari Division of No. 414 Panliyadda of Ihala Othota Korale Minor Division in Ibbagamuwa Divisional Secretary's Division in Kurunegala District in North Western Province.

Name of land : Endarugollewewatta; Description: Garden contains a coconut cultivation; Claimant : State; Extent : 3.999 Hectare.
