### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Notice under Section 7

I, hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for a public purpose.

Description of the land to be acquired :

Five (05) allotments of land shown as Ladupathyaya, F. V. P. 1344 (Supplement Sheet) No. 02 and Lot Nos. 5, 6, 7, 8, 9, situated in the North Western Province in Kurunegala District in Divisional Secretariat of Ganewatta in Mahagalboda Egoda Korale Othuwela Grama Niladhari Division 466, in Walakumbura and bounded as follows.

**01. Lot No. 05 – Extent: 0.0183 Hectare**
