##### Declaration under Section 5

By virtue of the powers vested in me under Section 5 of the Land Acquisition Act, as amended by Land Acquisition (Amendment) Act No. 28 of 1964, I, Chamal Jayantha Rajapaksha, Minister of Agriculture Development do hereby declare that the land described below will be acquired under provisions of the said Act as it is required for a public purpose:
