### Government Notifications

**SRI LANKA PORTS AUTHORITY ACT, No. 51 OF 1979**

#### Order under Section 25 (1)

BY virtue of the powers vested in me by Section 25 (1) of the Sri Lanka Ports Authority Act, No. 51 of 1979 as amended by Act, No. 07 of 1984, Act, No. 35 of 1984 and by Act, No. 2 of 1992. I, Chamal Rajapaksa, Minister of Ports and Aviation do by this Order approve under Section 25 (1) of the Sri Lanka Ports Authority Act, the acquisition of the lands specified in Schedules Nos. 1 to 12 hereto being required for the purposes of the business of the Sri Lanka Ports Authority, a Statutory Body established by the aforementioned Act, published as Supplement to Part II of the *Gazette of the Democratic Socialist Republic of Sri Lanka* of August 03, 1979 to be acquired under the Land Acquisition Act, and transferred under that Act, to the Sri Lanka Ports Authority.
