I, Jeewan Kumaranathunga, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Four (04) allotment of land in total extent of about 20.2929 Hectares, depicted in Advance Tracing No Maha/Pan/2001/340 prepared by the Surveyor-General situated in the village of Thawalanthenna in the Divisional Secretary's Division of Panvila in Kandy District and bounded as follows:
