THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Jeewan Kumaranathunga, Minister of Lands and Land Development, do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Six (6) allotments of land in extent of about 0.153 Hectare, depicted in Advance Tracing No. GA/GND/04/65 of 05.12.2004, prepared by the Surveyor-General, situated in the village of Udugama in the Divisional Secretary's Division of Gangaboda Pattuwa North, Naogda in Galle District and bounded as follows:
