**THE CUSTOMS ORDINANCE (CHAPTER 235)**

**Order under Section 10A**

BY virtue of the powers vested in me under Section 10A of the Customs Ordinance (chapter 235) as amended by Act, No. 83 of 1988, read with Article 44(2) of the Constitution of the Democratic Socialist Republic of Sri Lanka, I, Mahinda Rajapaksa, President of the Democratic Socialist Republic of Sri Lanka with the approval of the Cabinet of Ministers, do by this order levy on all imported goods except those specified in Schedule hereto, a surcharge of 15% on Customs Duty, both General and Preferential, from 08th November, 2007 till 31st December, 2008.

Order made under Section 10A of the Customs Ordinance and published in *Gazette No. 1497/7* of 14th May, 2007 is hereby rescinded.

**SCHEDULE**

The above order under Section 10A of the Customs Ordinance shall not apply to the following goods falling under the following Chapters, Headings and Sub-headings of the Customs Tariff, being Schedule 'A' to the Customs Ordinance (Chapter 235).
