#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Notice under Section 7

I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for a public purpose.

Description of the land to be acquired :

The land depicted in the plan No. F. V. P. 72, explain in the trace of page II and situated in the village of Karangoda which belongs to the Grama Niladhari Division of Karangoda, Pallepaththuwa, Nawadun Korale coming within the area of authority of Elapatha Divisional Secretariat in the District of Rathnapura in Sabaragamuwa province.
