#### PROVINCIAL COUNCIL (PAYMENTS OF SALARIES AND ALLOWANCE) (AMENDMENT) STATUTE No.....OF 2007

A Statute of further amend the Provincial Council (Payments of Salaries and Allowances) (Amendment) Statute No. 03 of 1989 by the Provincial Council of the North Western Province.

Be if passed by the Provincial Council of the North Western Province of the Democratic Socialist Republic of Sri Lanka.

1. This Statute may be cited as the Provincial (Payments of Salaries and Allowances) (Amendment) Statute No..... of 2007 Provincial Council of the North Western Province. Short Title.

2. (i) Section 2 (ඉ) of the Principle Statute is hereby amended by the substitution for the words Rupees Ten Thousand of the words Rupees Fifteen Thousand. Amendment of Section 2(ඉ) 2(ඊ) of the Principle Statute.
- (ii) Section 2(ඊ) of the Principle Statute is hereby amended by the substitution for the words Rupees Seven Thousand Five Hundred of the words Rupees Ten Thousand.

03. In the event of any inconsistency between the Sinhala and Tamil text of the Statute the Sinhala text shall prevail. Sinhala text to Prevail in case of inconsistency.
