I, hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, as Amended by the Land Acquisition (Amendment) Act, No. 28 of 1964 that the Government intends to acquire the following lands, which is required for the public purpose :-

Description of the land to be acquired :

Five (5) allotments of land called “Halbarawawatta” in extent of 4.3555 Hectare, shown as Lot Nos. 1 to 5 in Preliminary Plan No. Co. 8860 dated 27.08.2007 prepared by the Surveyor General, situated in Mulleriyawa Village, in the Divisional Secretary’s Division of Kolonnawa, Colombo District and Western Province and described as Schedule - 1.
