Land Acquisition Notices

THE LAND ACQUISITION ACT (CHAPTER 460)

Notice under Section 7

Reference No.: 3/1/451/2.

I hereby give notice under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for a public purpose.

Description of the land to be acquired:

Nine (09) allotments of land in total extent of about 8.295 Hectares, depicted in F.V.P. 86, Sheet No. 2, Supplement No. 1 and Lot Nos. 5 to 17, situated in the village of Rabegama in Mahagalboda Egoda Korale in Divisional Secretary's Division of Ganewatta in Kurunegala District in North Western Province and bounded as follows:

01. **Lot No. 5 – Rabegama Kele – Extent: 0.170 Hectare**

02. **Lot No. 6 – Rabegama Kele – Extent: 1.753 Hectares**
North: Lot No. 5; East: Lot No. 5; South: Lot Nos. 11, 14, 15 and 7; West: Lot No. 7 and Kalatuwakele village boundary.

North: Lot Nos. 14 and 11; East: Lot Nos. 10 and 18; South: Lot Nos. 17 and 16; West: Lot No. 14.

07. **Lot No. 14 – Rabegama Kele – Extent: 0.106 Hectare**
North: Lot Nos. 7, 6 and 5; East: Lot Nos. 11 and 13; South: Lot Nos. 13, 17, 16 and 18; West: Lot No. 15.

08. **Lot No. 16 – Rabegama Kele – Extent: 0.075 Hectare**
North: Lot Nos. 15, 14 and 13; East: Lot No. 17; South: Lot Nos. 17 and 18; West: Lot No. 18.

09. **Lot No. 17 – Rabegama Kele – Extent: 2.237 Hectares**
North: Lot Nos. 14, 13 and 10; East: Lot No. 18; South: Lot No. 18; West: Lot Nos. 18 and 16.

All persons interested in the aforesaid land, are hereby required to appear personally, or by agents duly authorized in writing, before me at the Assembly Hall, Rabegama, on the 11th day of March, 2008, at 10.00 a.m., and are hereby requested to notify to me in writing (in duplicate) on or before the 10th day of February, 2008, the nature of their interests in the land, the particulars of their claims for compensation for the acquisition of the said land, the amount of compensation and the details of the computation of such amount.
