CONSUMER AFFAIRS AUTHORITY ACT, No. 09 OF 2003

Direction under Section 12(1)

ACTING under the powers vested in it by Section 12(1) of the Consumer Affairs Authority Act, No. 09 of 2003, the Consumer Affairs Authority directs that no manufacturer, Importer or trader shall manufacture, import, sell or display for sale, expose for sale or offer for sale any Plain or Corrugated Asbestos Sheets unless such Asbestos Sheets are in conformity with the corresponding Sri Lanka standard specifications SLS 9/1 : 2001 for Plain Asbestos Sheets and SLS 9/2 : 2001 for Corrugated Asbestos Sheets respectively.

This Direction shall come into effect from 1st October, 2007.
