THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Fourteen (14) allotments of land in total extent of about 0.177 Hectare, depicted in the Advance Tracing No. Gam/Maha/2002/158, dated 10.09.2002, prepared by the Surveyor-General, situated in the villages of Kopiya Watta and Dalupitiya in the Divisional Secretary's Division of Mahara in Gampaha District and bounded as follows:
