##### Notice under Section 7

I, hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for a public purpose :

Description of the land to be acquired :

Land called Katukurundamandiyahena and Katukurundewatta containing about 1.4560 Hectare in extent depicted as Lot No. 01 in the Preliminary Plan No. 3985 dated 15.08.2007 prepared by the Surveyor General, situated in the village of Kumbuka, in the Minor Division of Kumbuka Pattuwa, in the Divisional Secretariat Division of Horana, in Kalutara District, of the Western Province and bounded as follows:

#### Lot No. 01 – Katukurundumandiyahena and Katukurunde Watta – Extent : 1.4560 Hectare
