I, Jeewan Kumaranatunga, Minister of Lands and Land Development, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for public purpose and will be acquired under the provisions of that Act.

Four (04) allotments of lands called Getamannaralagedeniya, Beligahakoratuwa, Getamannagedeniya, Getamannaralagedeniya, Gallegedeniya, Getamannagedeniya *alias* Beligahakoratuwa, Kahatagahawela, Gallagedeniya *alias* Beligahakoratuwa in total extent of about 0.1538 Hectare depicted as Lots A, B, C and D in Advance Tracing H/BLA/2007/375 of dated 20th August 2007 prepared by the Surveyor -General, situated in the Village of Puwakdanduwa (F.V.P.308) in the South Giruwapattuwa Minor Division in Beliatta Divisional Secretariat Area of Hambantota District, Southern Province and bounded as follows :
