### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Notice under Section 7

Reference No.: Kun/Ds/16/04/20.

Ministry of Lands and Land Development Ref. No.: 13/2000/WS/189.

I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for a public purpose.

Description of the land to be acquired:

An allotment of land called Bodigalawatta in total extent of about 0.0603 Hectare, depicted in the Preliminary Plan No. P.P Maha 5874, surveyed and prepared by the Surveyor-General, situated in the village of Degaldoruwa in the Minor Division of Udagampaha Korale, in the Divisional Secretary's Division of Kundasale in Kandy District and bounded as follows:

##### 01. Lot No. 1 – Bodigalawatta – Extent: 0.0146 Hectare

##### 03. Lot No. 3 – Bodigalawatta – Extent: 0.0200 Hectare

North, East and South: Bodigalawatta *alias* Kahalandahena claimed by W. W. Vigin and others; West: Bodigalawatta *alias* Kahalandahena claimed by W. W. Vigin and others and Lot No. 1.
