#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 05

I, Jeewan Kumaranatunga, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the Land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Three (03) allotments of land called “Nugagala Watta”, bearing an extent of about 19.851 Hectares, out of the total extent in Advance Tracing No. Maha/UDD/2006/273, dated 14th July, 2006, prepared by the Surveyor General, situated in the village of Hunnasgiriya (F.V.P. 429) in the Minor Division of Gampaha West in the Divisional Secretary’s Division of Udumbara of Kandy District in Central Province is given below:
