##### NOTIFICATION

BY virtue of the powers vested in me by Section 289 of the Municipal Council Ordinance (Chapter 252) read along with Section 02 of the Provincial Councils (Consequential Provisions) Act, No. 12 of 1989 I, Pestheruwe Liyanaralalage Reginold Rosmand Cooray Wijewarnasooriya, the Chief Minister and the Minister in-charge of the subject of Local Government of the Western Province do hereby make rules relating to the payment of allowances to the Mayor, Deputy Mayor and Members of the Municipal Council, with effect from 03.12.2008.

## REGULATIONS

1. These Regulations may be cited as regulations relating to the payment of allowances to the Mayor, Deputy Mayor and Members of the Municipal Council.

2. Allowances may be paid elected Mayor, Deputy Mayor and the Members of the Municipal Council at the following rates.

Mayor	—	Rs. 15,000.00
Deputy Mayor	—	Rs. 10,000.00
Member	—	Rs. 7,000.00

Entertainment allowances too, is included in the above.

3. (1) The Mayor, Deputy Mayor or the Members of the Municipal Council shall not have the right for the aforesaid allowances due to the following reasons.

- (i) Not attending to Council Meetings and Committee Meetings held during the months relating to the payment of allowances ; or
- (ii) Be under detention or imprisoned due to any criminal allegation ; or
- (iii) Except on medical grounds to be on leave with the approval of the Council.

Whatever, the period under detention or imprison or on leave, service can be counted as a part of a month, payments can be made in proportion to rest of the month.

3. (2) Whatever, the reasons given in sub paragraph one of the paragraph one of the regulation 3, on the occasion when the Mayor, Deputy Mayor or a Member is attending a duty with the formal approval, his allowances should not be suspended for being absence from a Council Meeting or Committee Meeting.
