#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Three (3) allotments of land in total extent of about 0.742 Hectare, depicted in Advance Tracing No. GA/BPP/07/1275 prepared by the Surveyor-General situated in the Village of Gaodakanda in the Divisional Secretary's Division of Bope-Poddala in Galle District and bounded as follows:
