##### LAND SETTLEMENT ORDINANCE

##### Settlement Order No. 1802 (Kurunegala)

WHEREAS a settlement notice under Section 4 of the Land Settlement Ordinance was duly published in the *Gazette* No. 745/20 of 18th December, 1992, and as otherwise required by the said Section, in respect of the lands situated in the village of Ihalahinukwewa in Nithalawa West Grama Niladari's Division of the Galgamuwa Assistant Governor's Division (Now Ehetuwewa Divisional Secretary's Division) in the Hathalispaha Korale of the Kurunegala District in the North Western Province and described as Lots no. 01, 02, 03, 04, 05, 06, 08, 09 and 10 in Block Survey Village Plan No. 3793 (*Vide* Settlement Notice No. 5491 : (Kurunegala).
