### Land Acquisition Notices

**THE LAND ACQUISITION ACT, (CHAPTER 460) AS  
AMENDED BY THE LAND ACQUISITION  
(AMENDMENT) ACT, No. 28 OF 1964**

**Declaration under Section 05**

*Reference No.: LD/05/2006/WS/397.*

I, Jeevan Kumaranathunge Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, as Amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that servitude over the land described below is needed for a public purpose and will be acquired under the provisions of the Land Acquisition Act. The said servitude will be acquired for the purpose of laying pipe lines of the project for the improvement of the Water Supply in the Matara District.

The allotments of land known by the names given below, and depicted in the Advance Tracing No. MR/DVN/2006/706 dated 30th June, 2007 made by the Superintendent of Surveys, Matara, and situated in the village of Talalla, Wellabadapattuwa West minor division of the Divisional Secretary's Division of Devinuwara, Matara District, Southern Province and containing in extent 0.0417 Hectare and bounded as follows :

**01. Lot A - Rolewa - 0.0026 Hectare in Extent :**

*On the North by* : Remaining portion of the same land claimed by G. B. Dias Dharmasena and (Pradeshiya Sabha) Road ;

*On the East by* : (Pradeshiya Sabha) Road ;

*On the West by* : Lot E.

**04. Lot S - Rolewa - 0.0163 Hectare in Extent:**

- On the North by* : Remaining portion of the same land claimed by Kapila Gunawardhana, Rolewa, claimed by N. T. A. Wijeratne and Lot E ;
- On the East by* : Lot E and (Pradeshiya Sabha) Road ;
- On the South by* : (Pradeshiya Sabha) Road and Lot G ;
- On the West by* : Lot G and the remaining portion of the same land claimed by Kapila Gunawardhana.

**05. Lot H - Ketlaketihera - 0.0003 Hectare in Extent:**

- On the North by* : Remaining portion of the same land claimed by N. D. Punchinona, Rolewa and Lot G ;
- On the East by* : Lot G and (Pradeshiya Sabha) Road ;
- On the South by* : (Pradeshiya Sabha) Road and Lot J ;
- On the West by* : Lot J and the remaining portion of the same land claimed by N. D. Punchinona.

**06. Lot J - Ketlaketihera - 0.0017 Hectare in Extent:**

**THE LAND ACQUISITION ACT, (CHAPTER 460)****Declaration under Section 05**

*My Reference No.:* LD/05/2008/VE/290.

I, Jeevan Kumaranathunga, Minister of Lands and Lands Development, here by declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provision of that Act.

**Description of the Lands :**

Two (02) allotments of land called Pattiyawatta Galapallehena in total extent of about 0.8339 Hectare, depicted as Lot No. 01 and 02 in Advance Tracing No. KE/DHO/2008/127 and dated on 10th September, 2008 prepared by the Surveyor-General situated in the village of Maniyamgammana in the Divisional Secretary's Division of Dehiovita in the District of Kegalle in Sabaragamuwa Province.

**01. Lot No. 01 - Pattiyawatta Galapallehena - Extent - 0.8094 Hectare:**

- North* : The partition of the same land, Werakadagalapallehena and Galapallehena or Henlapala ;
- East* : Werakadagalapallehena, Galapallehena or Henlapala, Kurahanwatta and Polkotuwawatta ;
