#### THE URBAN DEVELOPMENT PROJECTS (SPECIAL PROVISIONS) ACT, No. 2 OF 1980

##### Order under Section 2

BY virtue of the powers vested in me under Section 2 of the Urban Development Projects (Special Provisions) Act, No. 2 of 1980, I, Mahinda Rajapaksa, President of the Democratic Socialist Republic of Sri Lanka upon the recommendation of the Minister-in-charge of the subject of Urban Development, being of the opinion that the lands specified in the Schedule hereto are urgently required for the proposed By-Pass Road under the Hanwella Town Development Project do by this order, declare that the said lands are required for the said purpose.
