THE BOARD OF INVESTMENT OF SRI LANKA ACT, No. 4 OF 1978

Order under Section 22A

BY virtue of the powers vested in me by Section 22A of the Board of Investment of Sri Lanka Act, No. 4 of 1978, I, Mahinda Rajapaksa, President of the Democratic Socialist Republic of Sri Lanka, do by this Order declare that the areas of lands specified firstly and secondly in the Schedule hereto, to be a Licensed Zone for the purposes of this Act.
