ACTING under the powers vested in it by Section 10 (1)(b) (ii) of the Consumer Affairs Authority Act, No. 09 of 2003, the Consumer Affairs Authority directs that no manufacturer, trader or distributor shall sell, expose or offer for sale, store, transport, distribute or buy or purchase any locally produced rice or paddy which is fit for human consumption directly for the manufacture of animal feed or otherwise as an ingredient for the manufacture of animal feed.

This Direction shall come into effect from 25th January, 2008.

Direction under Section 12 (1)

ACTING under the powers vested in it by Section 12(1) of the Consumer Affairs Authority Act, No. 09 of 2003, the Consumer Affairs Authority directs that no manufacturer, importer, distributor or trader shall manufacture, import, distribute, store or sell or display for sale, expose for sale or offer for sale, wholesale or retail any item of steel classified below unless it conforms with the corresponding Sri Lanka Standard Specification and bears the SLS Product Certification Mark issued by the Sri Lanka Standards Institution.

(i) Ribbed steel bars for the reinforcement of concrete	-	SLS	375
(ii) Plain steel bars for the reinforcement of concrete	-	SLS	26

ACTING under the powers vested in it by Section 12(1) of the Consumer Affairs Authority Act, No. 09 of 2003, the Consumer Affairs Authority directs that no manufacturer, distributor or trader shall manufacture, distribute, store or sell or display for sale, expose for sale or offer for sale, wholesale or retail any item of locally manufactured steel classified below unless it bears the SLS Product Certification Mark issued by the Sri Lanka Standards Institution ; and no importer, distributor or trader shall import, distribute, store or sell or display for sale, expose for sale or offer for sale, wholesale or retail any item of imported steel classified below unless it has been inspected and approved for sale under the Import Inspection Scheme operated by the Sri Lanka Standards Institution under the imports (Standardization and Quality Control) Regulations 2006 made under Section 20 of the Imports and Exports (Control) Act, No. 01 of 1969, as amended by Act, No. 48 of 1985 and Act, No. 28 of 1987.

(i) Hot rolled steel bars for structural and General Engineering purposes	-	SLS	949
(ii) Mild steel wire for general engineering purposes	-	SLS	139
(iii) Cold drawn mild steel wire for the manufacture of wire nails	-	SLS	7
