THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development hereby give notice, under Sub - section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

An allotment of land called “Malwatte” bearing total extent of about 0.0253 Hectare depicted as Lot “A” in the Advance Tracing No.: MAHA/MHN/2006/418 of 27.10.2006 prepared by the Superintendent of Surveys situated in the village called Malwatte in the division of Kandy, No. 16, of Minor Division of Gangawata Koralaya in Kandy and Gangawata Koralaya Divisional Secretariat in Kandy District and bounded as follows:
