THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Two (02) allotments of land in total extent of 28.109 Hectares, depicted in the Preliminary Plan No. Ku/92/653, dated 17th March, 2003, prepared by the Surveyor-General, situated in the villages of Walikumbura and Walakumbura in Uda Kaha Korale North Minor Division in Divisional Secretary’s Division of Narammala in Kurunegala District and bounded as follows:
