David of SJMS Associates of No. 2, Casle Lane, Colombo 04 shall be the liquidators for the purposes of the winding up and it is ordered that the said liquidators for the time being, do on the 27th June, 2008 next, and henceforth every three months file with the Registrar of Court, a report in writing as to the position of and progress made with the winding up of the said company and with the realisation of the assets thereof, and as to any other matters connected with the winding up as the court may from time to time direct. And it is ordered that no bills of costs, charges, expenses or special remuneration
