## Order under Section 98(3)

BY virtue of the powers vested in me under Section 98(3) of the Financial Amendment Statute No. 02 of 2006 of the Western Province Provincial Council, I, Pestheruwe Liyanaralalage Reginold Rosmand Cooray Wijewarnasooriya, Chief Minister and Minister of Finance, Planning, Law and Order, Local Government, Provincial Administration, Education, Transport, Employment, Cultural and Art Affairs of the Western Provincial Council, do by this order, amend with effect from 10.06.2008. The order made under the said section and published in *Gazette* Extraordinary No. 1543/39 of 04th April, 2008 as follows.

By the deletion of sub - paragraph (I) and the substitution therefore, of the following sub paragraph.

- (I) A pro rate tax shall be charged on the total market value of the prizes awarded at every prize competition held within the Western Province calculated in the following manner :

<i>Total value of the prizes</i>	<i>Pro Rate Tax</i>
Less than Rupees One Hundred Thousand	exemption
A pro rate tax shall be charged on the total market value of the Prizes	20%
