**THE FOREST ORDINANCE**

THE order under Section 3 “A” of the forest Ordinance (Chapter 451) as amended by Act, No. 13 of 1966, Act, No. 56 of 1979, Act, No. 13 of 1982, Act, No. 84 of 1988 and Act, No. 23 of 1995.

**The Order**

By virtue of powers vested in me by Section 3 “A” of the forest Ordinance (Chapter 451) as amended by Act, No. 13 of 1966, Act, No. 56 of 1979, Act, No. 13 of 1982 Act, No. 84 of 1988 and Act, No. 23 of 1995, I Patali Champika Ranawaka, Minister of Environment and Natural Resources do by this order declare the Morahela Forest bounded by the limits set forth in the schedule which was declared by *Gazette* No. 5206 of 03rd day of March 1893 and amended by *Gazette* No. 5241 of 08th day of September, 1893 as Morahela Conservation Forest from 15th day of July, 2008.

**SCHEDULE**

I. All the state lands located within the allotment of land called Boranjomuamukalana in extent 289 Acres, 1 Rood, delineated and described in lease plan 372 dated April 16th, 1890, situated in the village Pidaligannawela in the Uduwaggam Pattu of the Kadwatu Korale in the District of Ratnapura ; bounded on the North by Gahawattahena ; on the East by the Pinimadaoya ; on the South by Pidaligannawelagama claimed by S. D. Mahawalatenna, Ratemahatmaya, and the Wennaladola ; and on the West by the Diyanilakandura and land described in lease plan 371.

II. All the state lands located within the allotment of land called Meddegamamukalana in extent 1,019 Acres, 1 Rood, delineated and described in lease plan 371 dated April 16th, 1890, situated in the village of Meddegama in the Uduwagga Pattu of the Kadwatu Korale in the District of Ratnapura ; bounded on the North by Galbokkehena and Gahawattahena ; on the East by the land described in lease Plan 372 and the Diyanilakandura ; on the South by Meddegama Nindagama Claimed by S. D. Mahawalatenna, Ratemahatmaya, a road, the Karawaladola, the Udagan-oya, and Crown land called Detangalamukalana and Galbokkehena.

III. All the state lands located within the allotment of land called Rassagalmukalana in extent 704 Acres, 2 Roods, 32 Perches, delineated and described in lease plan 370 dated April 16th, 1890, situated in the village of Rassagala in the Uduwagga Pattu of the Kadwatu Korale ; bounded on the North by Rassagalhena claimed by Mahawalatenna Ratemahatmaya, the Uma-oya, the Alawattedola, the Kandapoladola, the Wawullenadola, the Heen-ela the Gonatuwa or Pettara-ela, and a road ; on the East by Galkortuwahena claimed by Ukkuhatana, Kehelkoratuwahena claimed by Punchkura, Crown and Land called Marangahamedamukalana, and land described in Plans 46,236 and 47,509 ; on the South by land described in Plan 45,361 ; and on the West by land described in lease Plan 369.

IV. All the state lands located within the allotment of land called Rassagalamukalana in extent 103 Acres, 3 Roods, 10 Perches, delineated and described in lease plan 368 dated April 16th, 1890, situated in the village of Rassagala in the Uduwagga Pattu of the Kadwatu Korale ; in the District of Ratnapura ; bounded on the North and East by Rassagalhena claimed by S. D. Mahawalatenna, Ratemahatmaya ; on the South by land described in lease Plan 369 ; and on the West by Lunugaladola and land described in lease Plans 369 and 367.

V. All the state lands located within the allotment of land called Rassagalamukalana in extent 327 Acres, 3 Roods, delineated and described in lease plan 367 dated April 16th, 1890, situated in the village of Rassagala in the Uduwagga Pattu of the Kadwatu Korale ; in the District of Ratnapura ; bounded on the North by a road, the Diyaweladola and Rassagalhena claimed by S. D. Mahawalatenna Ratemahatmaya, on the East by Rassagalhena claimed by S. D. Mahawalatenna Ratemahatmaya, the Tirianaketiyadola, and the Bulatwatta-ela ; on the South by lands described in lease plans 368 and 369 and Crown land ; and on the West by Crown land.

VI. All the state lands located within the allotment of land called Rassagalamukalana in extent 56 Acres, 16 Perches, delineated and described in lease plan 366 dated April 16th, 1890, situated in the village of Rassagala in the Uduwagga Pattu of the Kadwatu Korale ; in the District of Ratnapura ; bounded on the North by a road, on the East by Rassagalagama claimed by S. D. Mahawalatenna Ratemahatmaya ; on the south by the Hulu-oya and Rassagalhena claimed by S. D. Mahawalatenna Ratemahatmaya, and on the West Hulu-oya.

VII. All the state lands located within the allotment of land called Rassagalamukalana in extent 79 Acres, 22 Perches, delineated and described in lease plan 365 dated April 16th, 1890, situated in the village of Rassagala in the Uduwagga Pattu of the Kadwatu Korale ; in the District of Ratnapura ; bounded on the North by Rassagalhena claimed by Mahawalatenna Ratemahatmaya, and the Denagang-oya ; on the East by Rassagalagama claimed by S. D. Mahawalatenna Ratemahatmaya ; on the South by a road ; and on the West by land described in Plan 47,503.
