#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development, hereby declare under Sub-Section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

The Land Depicted as Lot A - D in Advance Tracing No: Nu/KTM/2006/209 and dated 31.01.2007, prepared by the Surveyor-General and total extent of about 1.1186 Hectares, situated at Niyangandora Village in Minor Division Udapane Koralya in the Divisional Secretary's Division Kotmale, in the District of Nuwara Eliya in Central Province and bounded as follows:
