THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Eight (8) allotments of land in total extent about 7.704 Hectares, depicted in Advance Tracing No. NU/WLP/2007/199, dated 24.12.2007, prepared by the Surveyor-General, situated in the village of Abaliyadda (F.V.P. 239) in Udapalatha Korale Minor Division in Divisional Secretary's Division Walapane in Nuwara - Eliya District in Central Province and bounded as follows:
